

## KEY INVESTOR INFORMATION

**Atlantic Capital - The Opportunistic Equity Fund (The "Sub-Fund") is a sub-fund of Protea Fund (the "Fund")**

## I (the "Class") – ISIN (LU1336950792)

The Fund has appointed FundPartner Solutions (Europe) S.A. as management company.

### OBJECTIVE AND INVESTMENT POLICY

The Sub-Fund aims at generating a risk adjusted return within the equity market, focusing at protecting the capital during adverse financial market conditions. During normal environment it will aim at generating income and capital gains.

The Sub-Fund will mainly invest in:

- equities of companies which are domiciled, headquartered or exercise the predominant part of their economic activity in US or European countries; and/or
- cash deposits and cash equivalents (money market instruments, money market undertakings for collective investment).

The investment manager intends to invest the Sub-Fund's assets in equities and equity related securities. However, at any time and on a permanent basis (as a measure of capital preservation), all or part of the assets can be invested in cash deposits, money market undertakings for collective investment and money market instruments.

The choice of investments will neither be limited by geographical area (except emerging markets limited to 10% of the Sub-Fund's net assets), economic sector, nor in terms of currencies in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed in a single country (or some countries) and/or in a single currency and/or in a single economic sector.

On an ancillary basis, the Sub-Fund may invest in any other type of eligible assets, such as equities other than those above-mentioned, undertakings for collective investment (UCIs). However, the Sub-Fund's

investments in units or shares of UCIs shall not exceed 10% of its net assets.

For hedging and for investment purposes, the Sub-Fund may use all types of financial derivative instruments traded on a regulated market and/or over-the-counter. Nevertheless, in normal market conditions, the investment manager intends to use listed options and futures offering an exposure to equities and currency derivatives (such as forward foreign exchange contracts).

#### Dealing Frequency

The net asset value for the Class is calculated weekly on each Friday. The cut-off time to submit subscriptions and/or redemptions orders is 12p.m. Luxembourg time on the bank business day preceding the relevant valuation day.

#### Distribution Policy

The Class is cumulative. No dividend will normally be distributed.

#### Class Currency

The currency of this Class is EUR.

#### Minimum Investment

This Class is reserved to institutional investors.

The minimum initial subscription amount is 100,000 EUR.

#### Why is this Sub-Fund in this Category?

The sub-fund aims to provide a long-term capital growth by investing in cash, equities and equity related securities. Therefore its risk/reward profile corresponds to the medium level on the SRRI scale.

#### Are there any other Particular Risks?

Risks that could affect fund performance and are not necessarily fully reflected in the risk and reward rating include:

- Liquidity risks: The sub-fund may invest part of its assets in less liquid securities. Those are securities that cannot easily be sold or exchanged

for cash without a substantial loss in value in certain market conditions. Those securities also cannot be sold quickly because of a lack of ready and willing investors or speculators to purchase the asset.

- Counterparty risks: The sub-fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the sub-fund.

- Credit risks: The sub-fund may invest a portion of its assets in debt securities. The issuers of these debt securities may become insolvent, which will mean that the securities will lose all or some of their value.

- Risks from the use of derivatives: The sub-fund may use financial derivatives instruments which may result in the sub-fund being leveraged and may result in material fluctuations in the value of the sub-fund. Leverage on certain types of transactions including derivatives may impair the sub-fund's liquidity, cause it to liquidate positions at unfavourable times or otherwise cause the sub-fund not to achieve its intended objective.

Leverage occurs when the economic exposure created by the use of derivatives is greater than the amount invested resulting in the sub-fund being exposed to a greater loss than the initial investment.

- Operational risks: The sub-fund may fall victim to fraud or criminal acts. It may suffer losses as a result of misunderstandings or mistakes by employees of the Management Company or by external third parties or may be damaged by external events, such as natural disasters.

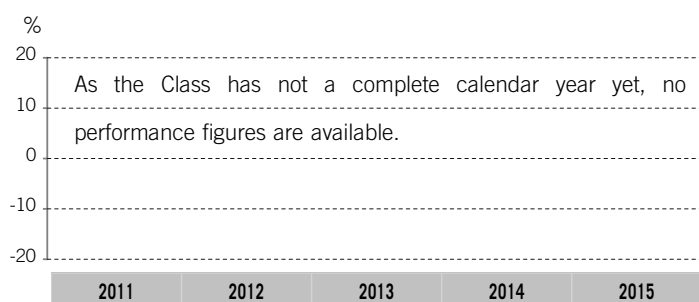
The charges you pay are used to pay the cost of running the Sub-Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
